# Year 10, End of Summer Term 2023 - Head of Year Message

As the end of the Summer Term draws to a close, on Wednesday 19 July at 12:30pm, I would like to update you on the progress this term.

I cannot believe that we are at the end of another academic year and that this cohort will soon be Year 11. They have completed a really successful start to their GCSE's. I am really happy to be continuing their school journey with them, and will continue to be their Head of Year into Year 11. The upcoming year is going to be filled with challenges and pressure but there is plenty of support available to students to navigate their final year successfully. One of the biggest changes comes through the tutor structure with PREP time being focused on Maths and Science which will be delivered on a carousel basis. Year 11 will also have an additional Period 5 lesson, this is a compulsory lesson and is part of their curriculum time. It is not an option that they do not attend it. We ask for your support in ensuring your child is fully aware of the expectation to attend. Lessons last from 3:10 pm - 4:10 pm Monday - Thursday.

We will also be holding Year 11 detentions on Friday after school between 3:10 pm and 4:00 pm. Students will be housed in Room 111 which will allow students to access revision materials and to complete coursework if necessary. It is highly unlikely many students in the year group will ever need to attend but please be mindful this is our expectation if sanctioned. Students have a clear academic journey ahead of them, one that they have had some input into, so the rewards will ultimately be based on their own effort and positive attitude towards their studies. In support of this please take time over the summer holidays to ensure that uniform and equipment is ready for the new term and that your child is feeling prepared for their final year of study of their chosen subjects.

# Equipment

The summer provides an excellent opportunity to replace and restock your child's equipment. A student that is not equipped, causes significant disruption to the learning environment and valuable learning time is lost as they are not organised. It also means they cannot be successful across the school day. We ask for your support with this, making sure you purchase items to support your child. A personal reading book, their own water bottle and a fully stocked pencil case to fully engage with their learning are the minimum required. Students will be provided with a student handbook and a place to write their timetable in, upon their return to school. Stationery equipment can be purchased from school via your ParentPay account.

# Uniform

We return in September in our Winter uniform (not polo shirts) and we ask that you resolve any issues you identify with your child's uniform in readiness for the start of term. In particular many students outgrow their school shoes during the summer, so please ensure that these are replaced in time. Any trainers that are purchased as school shoes need to be completely black all over including the sole. Blazers are a compulsory part of the school uniform. Hoodies are not allowed in school.

If students are without the correct uniform we ask that you provide them with a dated and signed note, and ensure that the issue is rectified within three days. This is a parental responsibility. Students attending school without the correct uniform and without a qualifying note will have break and lunch time removed until the issue has been resolved. In order to maintain our high standards of uniform this is the process we all must follow. Thank you for your support in advance.

# Jewellery

We are experiencing more challenges on a daily basis when it comes to students adhering to our Jewellery Policy. Jewellery is checked at Roll Call unfortunately a small number of students put their jewellery back on after Roll Call.

From September we will operate a policy similar to our Mobile Phone Policy 'see it, take it'. If a student is seen with the incorrect jewellery on them during the school day it will be confiscated and handed back at the end of the day. Our Jewellery Policy is very clear; students can wear one set of gold or silver studs, one discreet necklace that cannot be seen and one ring without a claw or raised setting. Any bracelet needs to be discreet, not laden with

If your child is getting their ears pierced over the holidays please ensure that if they choose diamante earrings then they can be removed and replaced with gold or silver studs. We have attached a copy of our Key School Policy Expectations for your reference.

### Start time

All students are expected to be on the school site by 8:40 am. The gates will be locked at this point and if students arrive later than 8:40 am they will be classed as late and issued a late detention.

#### **Mobile Phones**

All students in Year 7, 8, 9, 10 and Year 11 must hand in their mobile phone during morning tutor (Roll Call) as they are not permitted to have mobile phones in their possession. The phone should be silenced and notifications turned off. Students arriving late (after Roll Call) will be expected to hand their phone into Raising Standards for safekeeping. The phone will be collected by the 'lates team' when they enter via reception, if late without a valid reason they will incur a late detention to be served the same day after school.

Students who have a planned appointment, for example, the dentist must let their tutor know, then hand their phone into Raising Standards so that they can collect it at the appropriate time, when signing out of school.

Parents and students should be clear that the misuse of mobile phones will not be tolerated and failure to hand in their phone will be treated seriously by the school, as it is in clear breach of our rules. Parents wanting to communicate with their child during the school day should do so via the school office.

Students who misuse their mobile phone will be dealt with using the principle of "see it, hear it, and take it". If a student is found in possession of a mobile phone between 8.50 am and the end of the school day, communication will be made to home and the parent/carer will be responsible for visiting the school to collect the mobile phone by appointment.

We ask for your support with this and to explain our clear expectations to your child to avoid any conflict with staff. Full details of the school's Mobile Phone Policy can be found on the school website.

#### **Medical issues**

Please update the school regarding any changes in your child's medical history that will impact on our duty of care or compliance with standard school rules. Please email welfare@kgaeasthampstead.uk with any details. Our welfare team will be happy to discuss with you any changes to ongoing conditions or medication and you should make sure any out of date medicines are replaced if still needed.

# **Key School Policy Expectations**

Nails may be coated with a clear nail varnish.	Long acrylic nails are not appropriate for the school environment due to health and safety.
	Students that attend school with inappropriate nails will be asked to get them removed after 3 days from contact with parents. If they are not removed students may be sanctioned at break and lunch.
	No brightly coloured or patterned nails are permitted in school.
Earrings - One set of either gold or silver studs.	Multiple earrings are not allowed.
	Diamante style earrings are not allowed.
	Hoop style earrings are not allowed.
	Helix piercings are not allowed.
Years 7 - 9 No make-up is permitted. Years 10-11 Make up is to be natural in appearance.	False eyelashes are <b>not permitted</b> in school.
School shoes can be smart plain black shoes or plain black trainers.	White trainers or Black trainers with any colour on them are not permitted in school.
Mobile phones need to be handed in at Roll Call.	Students are not permitted to keep their phone on them, this is <b>not negotiable</b> , except for students who have their phone for medical reasons.
	Parents collect phones from school if found in a student's possession.
Jewellery:	
One bracelet.	Multiple bracelets, rings or visible necklaces are not allowed.
One discreet necklace (concealed under shirt).	Anklets are not allowed.
One discreet ring.	
All headwear must be discreet and black/navy blue in colour.
